



GENERAL COUNCIL OF THE JUDICIARY

Thirty-nine .-1.- In accordance with what is set out in article 87 bis of the Organic Law 6/1985, of 1 July, of the Judiciary, added by article 43 of the Organic Law 1/2004, of 28 December, regarding Integral Measures of Protection against Gender Violence,- in article 13 bis of the Law 38/1988, of 28 December, concerning districts and staff –added by article 50.2.c) of the same Organic Law 1/2004–, and what is set out in Annex XIII, introduced in the aforesaid Law 38/1988 by the eighteenth additional provision of the aforesaid Organic Law 1/2004, the Examining Magistrate's Courts or first instance civil and criminal courts listed below, assembled by autonomous communities and autonomous cities, will assume exclusive hearing of matters concerning violence against women in the terms of article 1 of the aforementioned Organic Law, harmonizing it with the rest of the matters corresponding to the criminal or civil jurisdiction, according to the nature of the organ in question:

2.- The rest of the Examining Magistrates' Courts or first instance civil and criminal courts of the legal districts affected by this measure hearing matters related to gender violence will continue, until their conclusion, hearing proceedings of this kind pending before them.

3.- The administrative and disciplinary divisions of the higher courts, in the performance of their functions and with prior proposal of the respective

**committees of judges, will adopt, where appropriate, the relevant Agreements concerning modification of distribution regulations or reduction of the same, when advisable by the entry of matters referred to by the Organic Law 1/2004, of 28 December, with respect to the Examining Magistrates' Courts or first instance civil and criminal courts for which the harmonization measure is now being adopted regarding the hearing of this specific matter and regarding the hearing of the rest corresponding to the criminal or civil jurisdiction.**

**4.- The present measure will take effect as of 29 June 2005.**
