



**Percentage of coverage by non-permanent staff (PCNP):** Relationships between the number of days in which positions of a concrete professional status have been occupied by non-permanent staff members, and the total of those professional status members, multiplied by 365. This is expressed as a percentage.

**Percentage of non-covered days (PNCD):** Relationships between the number of days in which positions of a concrete professional status have been uncovered, and the number of those professional status members, multiplied by 365. This is expressed as a percentage.

**Rotation index (RI):** Relationships between the number of investitures both of permanent positions and others, and the staff allocated for that professional status. This is a measurement of the stability of the staff.




